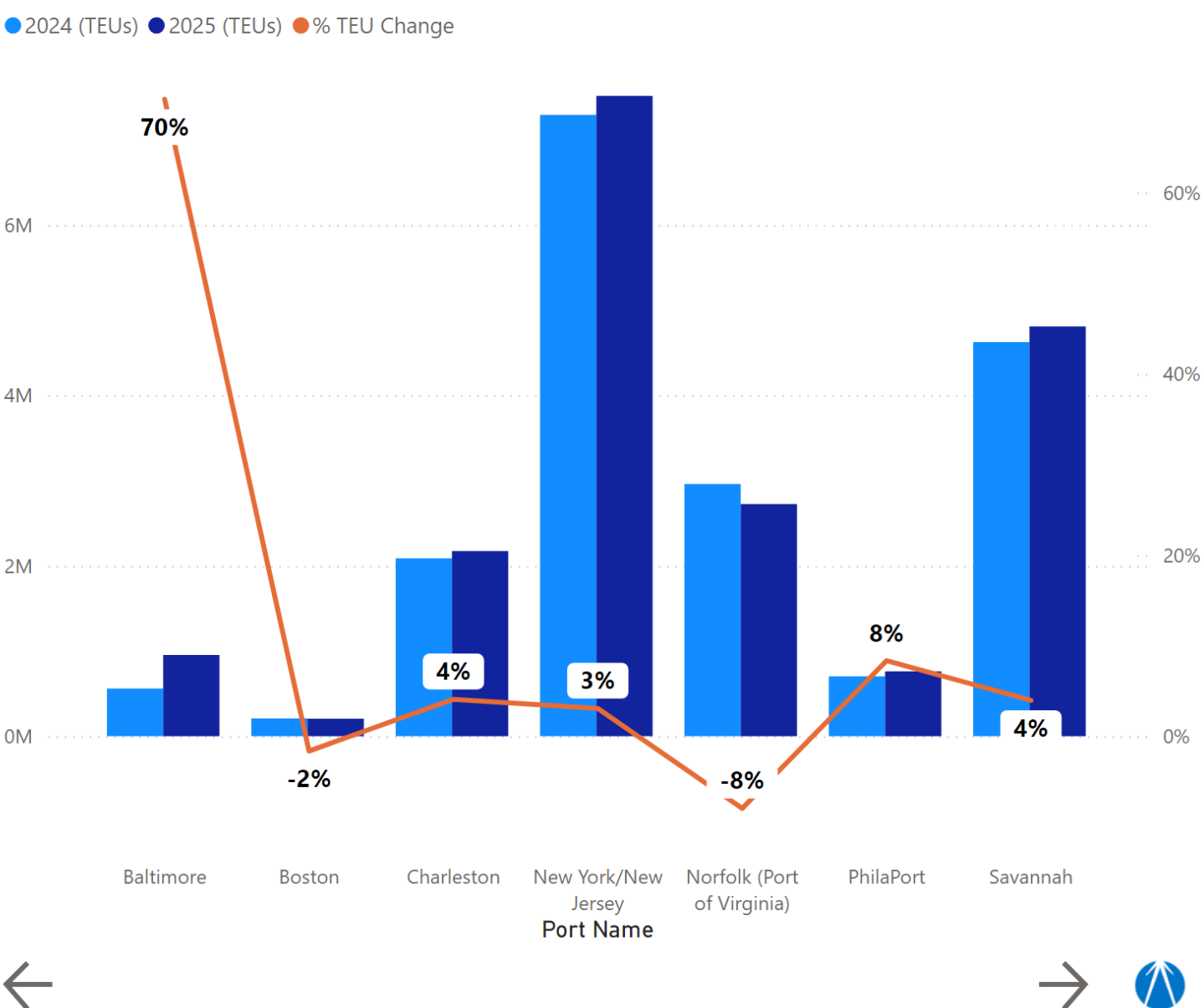

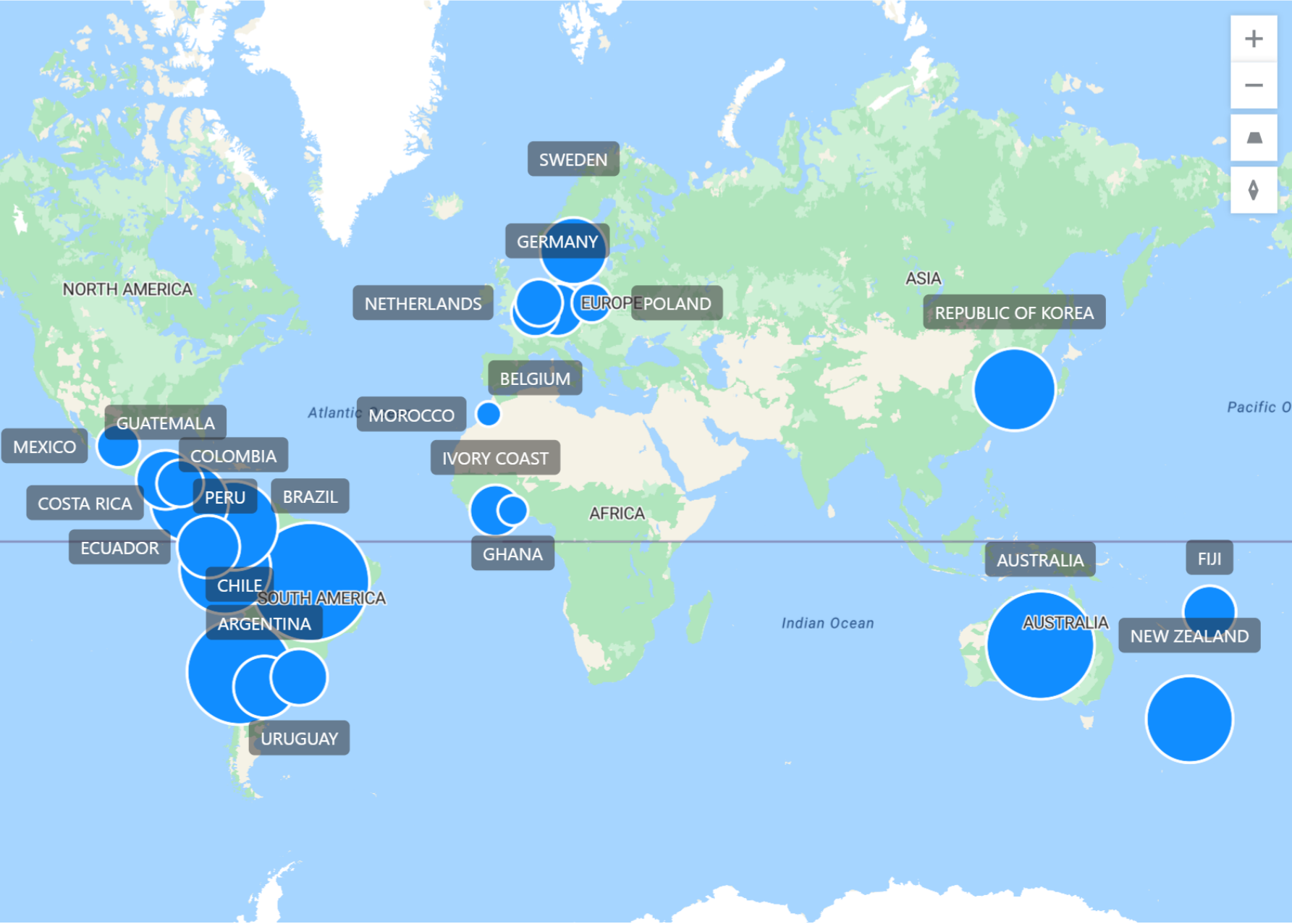

## **FAA / Cruise**

- Part 77 Permits
- Construction Crane 110' and 190' (HIGH PRIORITY)
- Engaged Senators McCormick, Fetterman and the House Delegation
- Review of ship when along-side is currently underway

## **Build America Buy America Waiver (BABA)**

- 2024 EPA Clean Ports Award \$47M for Tioga Cranes
- No domestic manufacturer
- Working with delegation for LOS (Chinese componentry a concern)
- Hanwha Philly Shipyard provided LOS

## **Legislation / Capital Itemization Act**

- HB-1331 (Capital Itemization Act) – 10/3 referred to Senate Appropriations Committee
- HB-1332 (Debt. Bill) – Allows for \$1.1B in Public Improvement Projects
- Senate back in session 1/26
